

# How we use your personal information

# **Visitors and Guests**

This statement explains how Selwyn College ("the College", "us" "we" "its") handles and uses data it collects about visitors, guests and attendees of the College ("you" and "your") for events and other reasons.

The controller for your personal data is Selwyn College, Grange Road, Cambridge CB3 9DQ. #### How your data is used by the College

In broad terms, the College uses your information to manage your visit or the event(s) you are attending, including dinners and accommodation and other needs requested by you, as well as to maintain records of previous, current and future attendees for events management for the College.

The legal basis for processing your personal information is that it is necessary in order for you to enter into a contract to provide facilities and resources to you. In many cases, you will be providing the personal information to the College, alongside consent for us to use that information to provide for your needs or otherwise to provide you with an improved service while you are at the College. We will retain your information for the periods stated below unless or until you request us to do otherwise.

The College collects and processes your personal information for the following purposes:

## A. To maintain clear contact information for the booking, provision and payment of services.

The College will hold your name, address, email address, phone number and other relevant contact details you provide and will use this information to maintain contact with you to provide your requested services, manage their delivery and bill you for them. We retain relevant information in our events records for up to 7 years after the most recent visit or event you attend. If you are a member of the College (including if you are a former student), we will provide the Development & Alumni Relations Office with your contact details in order for them to update their records, if you are happy for us to do this.

#### B. To provide you with necessary and preferred services.

Where relevant, the College will also collect data for the provision of services, your reason(s) for attending the event, your nationality and passport details, your car registration, your credit or debit card information and/or any service preferences you request specifically (e.g. room type, dietary requirements, access needs and other amenities requested). This may include you providing special category (sensitive) personal information. The College will not retain this information for any longer than necessary for the provision of the specific event or visit, which might require you to provide the information on successive occasions.

For guests who attend live streaming events, your images may appear in livestreaming/recordings and you will be advised of this when booking. The College uses a SALTO lock system which controls some door access, which will by its nature, record movements in and out of some areas, though this is not its primary purpose. Like all data we store, this information is kept confidentially. Please contact the Head Porter (headporter@sel.cam.ac.uk) if you have any questions about the SALTO lock system.

We also operate wifi which can be accessed by College guests which retains device information (such as physical MAC address and IP address) and details of the IP address the device is connected to for limited periods.

#### C. To provide you with details about future College events.

While the College retains your contact information, we may contact you about future College events or new facilities we believe may be of interest to you. You may unsubscribe from such communications at any time by emailing <a href="mailto:conferences@sel.cam.ac.uk">conferences@sel.cam.ac.uk</a>

#### D. To fulfil our legal obligations.

The College is required to keep for 12 months the names and nationalities of all those staying in College accommodation. In the case of nationals outside of the UK, Republic of Ireland and the Commonwealth, we must also keep a record of your passport details and next destination. We are also required to keep details relating to any financial transaction for a period of seven years.

The College will keep, until no longer required, the names and contact details of all those named in a College Incident, Near Miss or Accident Report.

Our room booking system (Mercury) and Electronic Point of Sale (EPOS) system which processes payments for items purchased through the Servery are processed by Accurate Solutions Ltd which has remote access permissions to our system and therefore access to the data contained therein. ### Your rights

You have the right to ask us for access to, rectification or erasure of your information; to restrict processing (pending correction or deletion); to object to communications or direct marketing; and to ask for the transfer of your information electronically to a third party (data portability). Some of these rights are not automatic, and we reserve the right to discuss with you why we might not comply with a request from you to exercise them.
